 - i. Tommy Scott indicated there is a citizen group interested in revitalizing the RC track. Tommy also discussed that future improvements to parks (including changes to the RC Track) are part of the Parks Master Plan, but spread over time and funded via the Capitol Maintenance Program.
 - Fred Pazona wants to know what the status is on the Bar Code Readers for membership.
 - Mike Koenig says that they have cards printed but that there are some technical issues that must be worked out before they can go live with the program.
 - Eric Toth Wants to know the status of Live Oak Point after Hurricane Irma.
 - i. Tommy Scott indicated that it is still being reviewed by FEMA.
